

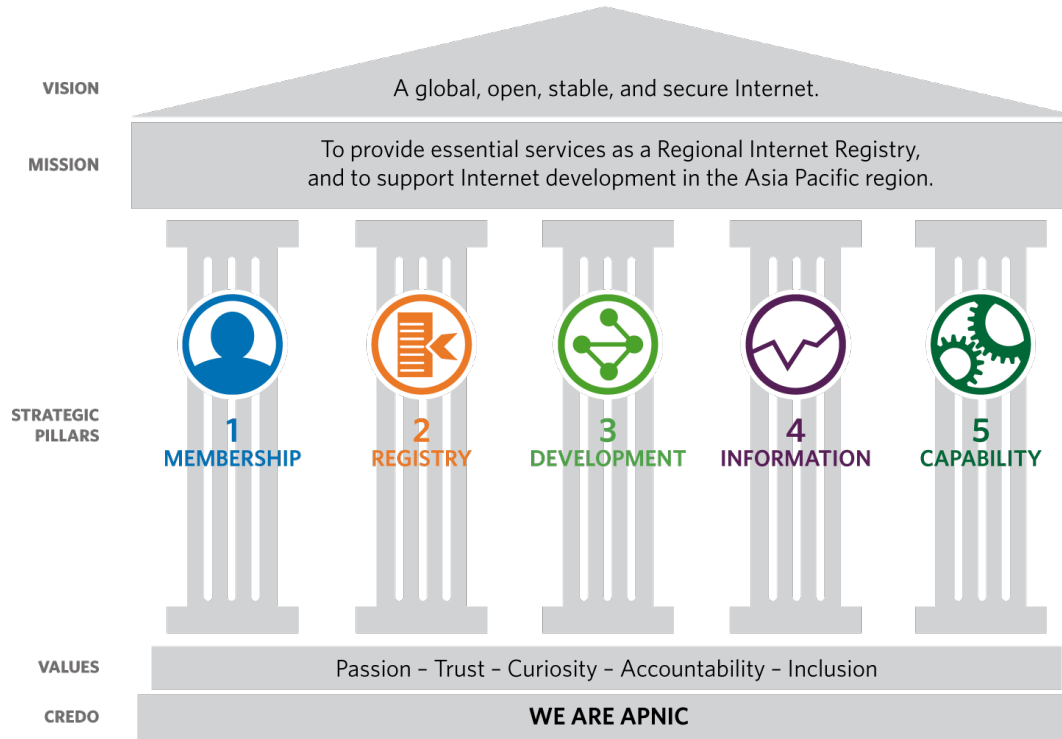

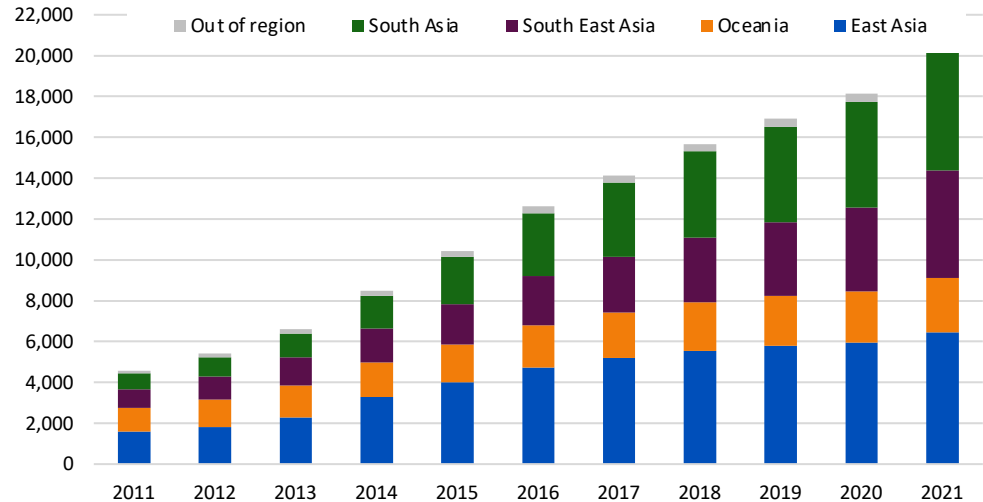
# 2022 Focus Areas

  - Designing and delivering services where they are most needed

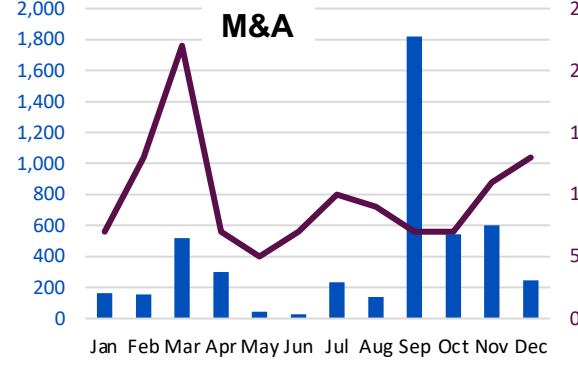
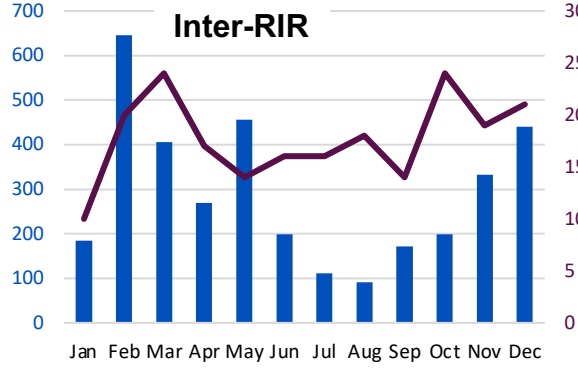
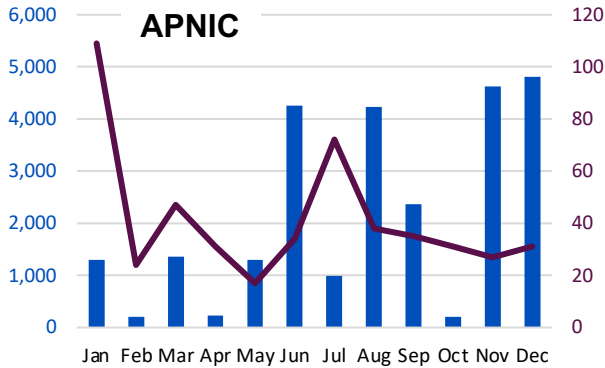
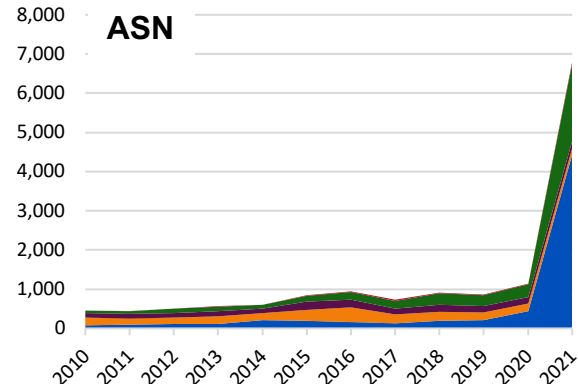
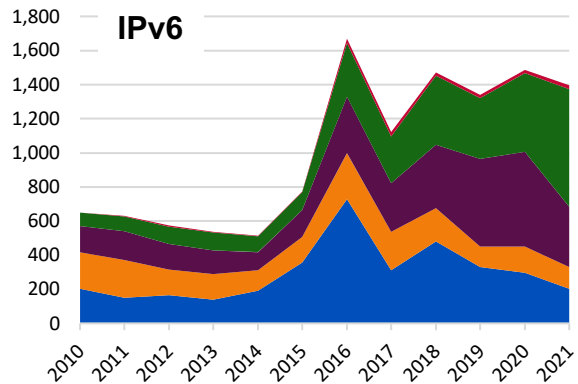
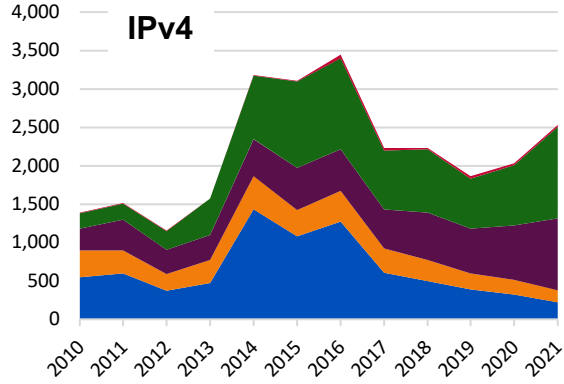
# Member Services

# IPv4 Address Pool

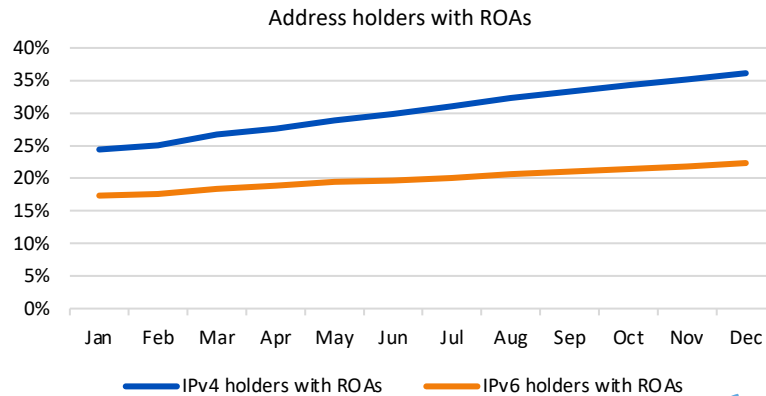
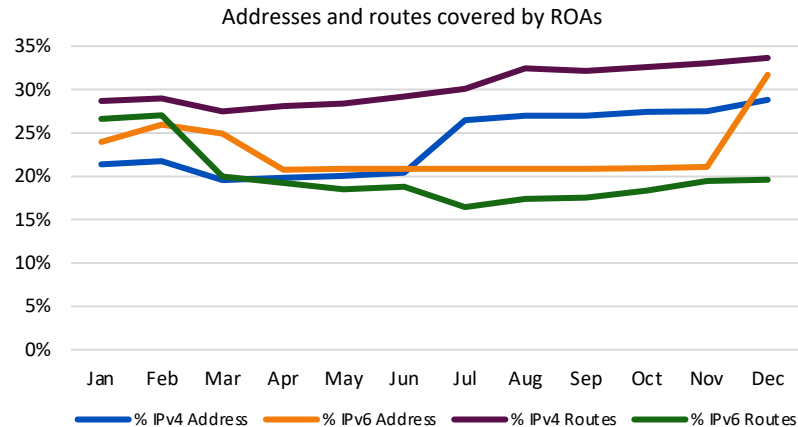


- IPv4 Reclamation
  - 1,909 /24s (488,704 IPv4) returned to APNIC voluntarily in 2021
  - 4,300 /24s (1.1M IPv4) to be reclaimed in 2022
- 99.4% IPv4 address pool allocated; 0.6% available
- New treatment of historical registrations
  - Membership required from 1 Jan 2023
  - Potentially 3000+ holders



- 11 CCs reached 90%+ ROA coverage
- 18 RPKI training events
- Five RPKI success stories
